Conditions of the Sale:

- Seller guarantees that this kitten is healthy to the best of their knowledge. This kitten is sold with a standard 72 hour health guarantee. Buyer has 72 hours to take the kitten to the vet for a health exam (confirmation of health), if any health concerns are found, the buyer may return kitten to the seller within 72 hours with a written explanation from the attending vet at the buyers expense for a full refund of the kittens purchase price. No medical, or veterinary or travel expenses will be refunded by the seller/breeder. During this first 72 hours, the kitten should be isolated from any other pets and monitored for health, eating, litter box usage and activity level. The seller is not responsible for any injury or illness to other pets caused by exposure to this kitten. Keep in mind that the seller/breeder has had your kitten examined by a licensed veterinarian prior to the sale of the kitten for sole confirmation of health, in addition to keeping the kitten current on age appropriate vaccines and deworming and testing (FeLV/FIV/HWT).
- Under no circumstances will this cat or kitten be sold, leased or given away to any pet store, research laboratory, breeding mill or similar facility.
- This cat or kitten will be kept indoors and not be allowed to roam freely outdoors.
- If this kitten was purchased intact (not spayed or neutered), it is agreed by the buyer that the kitten will be altered (spayed or neutered) by the time that the kitten reaches 7 months of age. Proof of alteration (Spay/Neuter) must be sent to the seller when the kitten is altered. Proof of alteration includes either a spay/neuter certificate from a licensed vet, or a copy of the vet bill showing and proving that the kitten was spayed/neutered by a licensed veterinarian. Seller/Breeder will then issue (mail/or email) CFF or TICA registration papers to the buyer within 30 days of receiving proof of alteration.
- Buyer agrees that this kitten/cat will not be declawed under any circumstances.

NuVet Plus Extended Health Agreement:

_____ (Buyers Initials). If you are agreeing to supplement your kitten for the 1st year of life with NuVet Plus Vitamins to qualify for the one year health guarantee, then please initial where indicated above. **NuVet Plus Vitamins Health Guarantee:** All of our kittens are sold with a standard 1st birthday guarantee which correlates with supplementing the kittens with NuVet Plus Vitamins for at least the kittens first year of life. If you desire to have your kitten guaranteed for the first year of life, then you are required to purchase or supplement your kitten(s) with the NuVet plus vitamins for at least the kittens first year of life. The 1st birthday guarantee will guarantee a one time replacement kitten at 1/2 the cost of the new replacement kitten if the kitten purchased in this agreement dies of a confirmed genetic, hereditary, congenital defect including FIP within it's first birthday. Veterinary proof will be required in the form of a letter from the kittens/cats veterinarian confirming death attributed to a Genetic/Hereditary/ Congenital defect including FIP. Laboratory reports, XRay's, Ultrasounds, and full veterinary records will be required by seller in this agreement as proof, including a Necropsy (Autopsy) should the kittens/cat's veterinarian not be able to find an evident cause of death. A Necropsy will give full determination as to the kittens/cats cause of death. Bear in mind that this is only needed in the event that a veterinarian cannot confirm with 100% surety what disease/illness/defect contributed to the kittens/cats' demise. Please keep in mind that NuVet plus sends me confirmation of customer orders (customers name only) for my Health Guarantee records. Proverbs Cats requires all buyers who choose an extended health agreement to supplement their new kittens with the NuVet Lab's Vitamin powder until the kittens reach the age termed in this contract (one year/1st birthday), to guarantee this health agreement. If at any time

prior to the cat/kitten's age termed birthday, the product is cancelled (auto-ship) and discontinued in the cat's daily regimen, all genetic/hereditary/congenital/FIP defect guarantees will no longer be valid.

Proof will be required in the event of a cat/kitten's replacement request, so it is strongly advised that you have proof of purchase receipts for all NuVet plus vitamin supplements purchased, as well as veterinary receipts and documentation proving a genetic/hereditary/congenital defect including FIP. If a definite diagnosis of a genetic/hereditary/congenital/FIP defect death cannot be determined clinically by a licensed veterinarian, then a necropsy (autopsy) will be required to confirm that the cause of death is due to a genetic/hereditary/congenital/FIP defect.

This health agreement does not cover death due to accidents, abuse, neglect, infection or disease brought on from exposure to another cat/animal, or the outdoors, or any random act of nature.

In order for this health agreement to take full effect, you must be:

On the NuVet plus AUTO-SHIPMENT PROGRAM for at least the kittens 1st year of life.

The AUTO-SHIPMENT PROGRAM is a valuable offer that saves you an average of about 15% off the regular purchase price. Auto-shipment ensures that you do not forget to order your pets vitamins and that your companion always has a fresh supply on hand.

Kitten buyer must place their first order at least 1 week prior to the kitten(s) being picked up or shipped based on the agreed upon time in the Deposit Agreement or Agreement of Sale contract.

Kitten Replacement Explained:

A replacement kitten will be provided at a discounted rate of 1/2 the purchase price from the sellers most current kitten prices in replacement of the original kitten purchased in this agreement. This replacement is a one-time only replacement. A new health agreement will not be provided for or towards the replacement kitten. Replacement kittens are sold 'as is with no extended health guarantees. Kitten replacements will not be free, and as mentioned will be provided at a discounted rate of 1/2 the purchase price from the sellers most current kitten prices.

In the event that a replacement kitten is to be shipped or hand delivered, the buyer will be responsible for any and all shipping expenses required to ship or hand deliver a replacement kitten to them.

Legal Details:

It should be mutually agreed by both the seller and buyer that if there are any disputes pertaining to the sale of the animals(s) sold in this agreement that they be resolved out of court and with a fair understanding by both parties. However, if any legal action is required to enforce the terms of this contract, such mentioned legal action will be brought forth in Los Angeles County in the state of

California. Buyer shall be liable for any court costs and related charges including attorney's fees associated with Seller enforcing the terms of this contract, or by the Seller having to respond to any legal claims by the Buyer.

Note: No alterations or substitutions or manipulations or write offs are allowed on any of the verbiage in this agreement without the seller/breeders express written consent. If clarification on any of the points in this agreement are needed please contact the breeder/seller directly to discuss those details.
