NOTE: The deposit is payable in the form of a personal check, cashiers check from your bank, PayPal (Friends & Family Only), Zelle, or a postal money order. A deposit payment of \$500.00 per kitten is required to reserve a kitten or to be added to our waiting list. Please make all payments payable to breeder/seller: Sonni D. Garcia.

Deposits will remain on file and active for a period of one year from todays date (date on the deposit agreement). There is no cooling off period, and deposits are generally non-refundable with a few exceptions: Exception #1. This deposit agreement can be cancelled by the seller (breeder) at any time, for any reason, and a full deposit refund will be provided to the buyer if the breeder cancels the sale of this kitten or cancels the promise of a kitten through the waiting list. Exception #2. The seller is unable to produce a kitten matching the buyers preferences within the one year deposit term, and then has no choice but to refund the deposit and cancel the waiting list process with the buyer.

**Deposit Forfeit Details:**

Deposits are forfeit by the buyer and will not be refunded if the buyer:

1. Does not accept kittens that are offered matching their preferences up to three (3) different times within the one year term period from the date on this agreement. If the buyer declines that 3rd/last kitten offer, the deposit will be forfeit and the buyer will be removed from all Proverbs Cats waiting lists. Please be sure to let the seller know if your preferences ever change for breed, color point, gender, and of any dates in which you could not possibly take a new kitten home to avoid this rules implementation, and subsequent deposit forfeiture.
2. The Buyer forfeits the deposit if the kitten is not picked up as scheduled without any prior communication/arrangement, or if the final balance including all shipping or delivery fees are not paid at least a week before the kitten is to be shipped out or hand delivered as originally scheduled by the seller, and acknowledged by the buyer. This is strictly enforced if the seller has determined that the buyer has abandoned interest in the kitten(s) with or without prior communication from the buyer.
3. The Buyer forfeits the deposit if the buyer has declined at least one kitten within the one year time time period, and a subsequent kitten offer cannot be made because the buyer keeps changing their preferences for breed/color point/gender/pattern.

**Final Balance Details:**

Final payment must be made in form of cash at the time that the cat/kitten is to be picked up in person. However, the final payment can be paid in advance in the form of a cashiers check or a postal money order or by Zelle or PayPal (Friends & Family) in the event that the kitten is being shipped as 'live cargo' via the airlines to the buyer or hand delivered. Kitten(s) must be picked up or shipped no later than 12-14 weeks of age unless otherwise discussed and agreed by both seller/buyer.

**Boarding Fee Details:**

There will be a \$25.00/per day daily boarding fee until the cat/kitten is picked up in the event that the buyer is unable to pick up the kitten on the original go-home date that the litter is scheduled to leave on. Seller has the right to accept or decline a buyers request for a kittens extended stay past the go-home date. The \$25.00 daily boarding fee does not apply however if it is the seller who decides to re-schedule the kittens pick-up appointment.

**Kitten Selection Details:**

Once the buyer chooses a kitten the buyer cannot switch kittens, unless the seller allows it, and if the original kitten is less than 8 weeks old at the time that the buyer changes his/her mind about that particular kitten. Please understand that if you decide to switch kittens the price may differ from the original price agreed to in this deposit agreement form.

This deposit agreement serves as proof of deposit & receipt once it bears sellers signature & date. Seller will promptly mail (or e-mail) a signed/dated copy of this deposit agreement back to the buyer once the seller receives the original deposit contract form and deposit payment. No alterations or changes are allowed on this agreement. Please do not alter any of the verbiage on this agreement without the seller/breeders express written consent.
